# Notice of Intent to Adopt Mitigated Negative Declaration for City of Lathrop Manthey Road Bridge Replacement Project

### What's Being Planned?

The City of Lathrop (City), in cooperation with California Department of Transportation (Caltrans), proposes to replace the Manthey Road Bridge to address issues of safety and circulation and to improve bicycle and pedestrian access. The replacement bridge will be along the proposed Golden Valley Parkway alignment. The City is the lead agency under CEQA and Caltrans is the lead agency under NEPA.

#### Why This Notice?

The City and Caltrans studied the effects this project may have on the environment and circulated the Draft IS/EA on September 11, 2020. This notice is to tell you of the preparation of the Recirculated Focused IS and proposed MND, which presents enhanced mitigation for impacts on two special-status species, Swainson's hawk and riparian brush rabbit. The Recirculated Focused Initial Study is available for you to read and participate in a public review and comment.

This document presents revised and enhanced mitigation to reduce impacts on Swainson's hawk and riparian brush rabbit to a less than significant level in response to comments on the Draft IS/EA from California Department
