### Overview

Voter approval of the City of Lathrop Public Safety & Essential City Services Measure (Measure C) in November 2012 authorized the collection of one cent transaction and use tax effective April 1, 2013. The City began receiving from Measure C in September 2013.

Measure C allocates 40% of its revenue collected to the Lathrop Manteca Fire District (LMFD) to augment and enhance fire protection activities with the City. The remaining 60% of Measure C funds are used by the City to maintain and enhance police and other essential City services. All Measure C expenditures are approved by the City Council and reviewed by the Measure C Community Oversight Committee for conformance with the intent of the Measure.

- Fund Housing Assistance Program for Sworn LMFD Staff

### **Public Safety**

Continue to fund sworn public safety positions to promote a safe environment in the community focused on prevention, intervention and outreach.

- Fund 9.5 Sworn Police Positions
- Funded Housing Assistance Program for Sworn LPD staff

### Lathrop Manteca Fire District

- Fund 9 Firefighter Engineers, 1.98 Battalion Chiefs & 1
   Deputy Fire Marshal Positions
- Fund OT for constant staffing at all City of Lathrop Stations
- Fund personnel expenses related to incentives and licensing to provide paramedic services
- Fund Housing Assistance Program for Sworn LMFD Staff



### Goals

### **Essential City Services**

- Parks and Recreation
  - Continue to fund support position and maintenance and operation costs for the Lathrop Generations Center.
- Fund CIP Projects totaling \$2.76 million:
  - PK24-04 Mossdale Community Park Renovations \$1.78 million
  - PK25-01 Valverde Park Revitalization \$1.78 million
  - GG26-02 Citywide Fiber Optic Improvements \$250 thousand
