### FIRE SEASON IS COMING, LET'S PRACTICE FIRE PREVENTION MEASURES TODAY!



To help keep residents safe, the Lathrop - Manteca Fire District would like to remind you that it is time to remove any overgrown vegetation likely to be a fire hazard on your property. This includes weeds, dead, decayed, diseased or hazardous trees, and other vegetation constituting an unsightly appearance or dangerous to public health, safety, and welfare. (City of Lathrop Municipal Code 8.24.30)

Weed abatement ensures that property owners maintain a defensible space around their properties that would allow firefighters to effectively stop fires from spreading from open space areas to homes and other structures. Cutting grass and weeds reduces the ability for fire to start or spread quickly and decreases the fire risk in our city. Additionally, removing flammable plants and debris in proximity to a home increases the chances of that home's survival in the event of a fire.

We are aiming at having 100% compliance in the City of Lathrop no later than June 1st and our staff will be conducting regular inspections of the community to ensure any issues are being addressed. Please note, properties should be consistently maintained, as there is a potential for re-growth throughout the fire season.

Please help keep Lathrop safe with the abatement of weeds, and by following these fire prevention tips:

- · Mow or disk during cooler weather, preferably the early morning, but never when it's windy or excessively dry.
- Lawn mowers are designed to mow lawns, not weeds or dry grass. Metal blades striking rocks can create sparks and start fires. Please use caution.
- Never pull your vehicle over in dry grass.
- Make sure all portable gasoline-powered equipment have spark arresters.
- Keep all weeds and grasses below 4 inches in height in residential areas.
- Remove all dead vegetation/debris from your property, including dead or diseased trees.

## COMMERCIAL WASTE & RECYCLING REQUIREMENTS



It is the desire of the City of Lathrop to create and maintain a beautiful, environmentally conscious city while complying with all state required mandates related to solid waste and recycling. Below is a list of Commercial Waste and Recycling Requirements. For additional information, visit our website at www.ci.lathrop.ca.us/parksrec.

### **Mandatory Commercial Recycling (AB 341)**

Per AB 341, State Law requires that all businesses and multi-family housing complexes that generate at least four (4) cubic yards of solid waste a week to arrange for recycling services.

### **Mandatory Commercial Organics Recycling (AB 1826)**

Per AB 1826, State Law requires that all businesses and multi-family housing complexes that generate at least two (2) cubic yards of solid waste a week arrange for organic waste recycling services.

### Mandatory Organic Waste Reduction (SB 1383)

The Short-lived Climate Pollutant Reduction Act of 2016, is geared to reduce organic waste disposal by 75% and increase edible food recovery by 20% by 2025. To comply with this state mandate, all solid waste generators will need to subscribe to organic/green waste (e.g. yard trimmings, food waste) collection services. Additionally, it requires that qualifying businesses including supermarkets, grocery stores, food distributors, restaurants and hotels to redirect edible food from landfill to food recovery organizations.

#### **DI Minimis Waiver**

### **Industrial Haulers**

The City of Lathrop contracts with Republic Services to provide residential and commercial garbage service, however, the City of Lathrop does approve industrial Hauler Licenses each fiscal year. (LMC 816.010) The license is required for ALL hauling of Industrial Solid Waste, which applies to manufacturing facilities, factories, and refineries. Republic Services is the franchise hauler for recycling and disposal of C&D materials including, development, new construction, and remodels. Please call (209) 466-5192 and select option 2.

### **GOT ANTS IN YOUR PLANTS?** TIPS FOR REDUCING PESTICIDE USE IN YOUR GARDEN

Spring is here, and you might not be the only one excited garden? Here are a few tips to identify and attract beneficial to get back into your garden. Whether it's weeds, bugs, rodents, or other pests, your garden may be experiencing some unwanted visitors. Before you reach for a pesticide, consider these tips to care for your outdoor space without using harmful chemicals. Reducing pesticide use can save you money and help protect our local waterways!

### **Garden Maintenance Tips to Prevent Pests**

One of the best ways to manage pests is to prevent them from settling in your garden in the first place. You can do this by removing things that attract pests, such as food, water, and shelter. Here's how:

- Remove trash and yard waste - Trash and decaying plant material often attract insects and rodents. Remove and properly dispose of any trash or yard waste.
- Use physical barriers Row covers, hot caps, and other plant cages can help keep pests away from sensitive young plants. Sticky barriers, copper barriers, and raised beds are other options that can help protect garden plants.
- Remove standing water
- Standing water can

encourage the growth of mold and algae, become a nursery for insect larvae, and attract unwanted animals looking for drinking water. Be sure to remove standing water to reduce the chances of pests turning your yard into their home.

• Plant smart - Planting strategies, such as selecting appropriate types of plants, alternating plant patterns, and adding ground cover (like mulch) can deter pests. For more information about planting strategies, visit https://ourwaterourworld.org/health-garden/.


### Friend or Foe: Beneficial Insects

Most bugs are friends, not foes! In fact, 97% of the insects you see are considered good. These are called "beneficial" insects" because they benefit your garden by pollinating your plants, improving the soil, and eating the pests that harm your garden. How can you invite more friends to your

insects:


• Find your friends – Many insects are natural enemies of common pests; you just might not recognize them! Find out

who your friends are by learning how to identify beneficial insects. insect can dramatically during each stage of its life cycle, such as egg, larva, pupa, and adult. It is important to know what the good bugs: such as bees, ladybugs, soldier beetles. and green lacewings, look like in their various life stages.



that beneficial bugs will find your garden welcoming and stick around.

• Use pesticides as a last resort – While pesticides can control pests efficiently, they will also likely harm or kill the beneficial bugs. If pests are present in your yard, first try non-toxic or less-toxic methods, such as traps, deterrents, and preventative measures, to ensure your gardening strategies are sustainable and environmentally friendly.





### Did You Know?

The stores where you buy pesticides can help you choose a less-toxic option! Next time you're shopping for pest control products, look for "point-of-purchase" signs, such as shelf edging or tags, as well as display stands with fact sheets, banners, and other educational materials. RLF loans serve to finance various aspects of business assets and operations, covering a spectrum of needs including inventory, equipment purchases, tenant and leasehold improvements, working capital, startup expenses, and acquisition of buildings or land.
