#### 1. DISTRICT ANALYSIS

#### 1.1 District

Community Facilities District No. 19-1 (South Lathrop City Services) (the "District") was formed in April 2019 to pay for Services including the ongoing maintenance and operation of public roads, medians, street lights, traffic signals, traffic signs, frontage improvements, landscaping, drainage facilities, and standby charges related to the ongoing maintenance and operation of the public improvements. The special tax may be levied in perpetuity.

#### 1.2 Levy

For Fiscal Year 2019/20, the District levied \$521,361.14 on nine parcels. This is the first year of the Special Tax Levy.

All parcels are Undeveloped and levied at 100% of the Maximum Special Tax.

#### 1.3 Special Issues

NBS will work with the City to review payment information and monitor delinquencies after each installment date.

Senate Bill 165 reporting will begin in the Fiscal Year 2019/20 when the first Special Tax Levy is collected.
