
Measure C Community Oversight Committee Regular Meeting, January 24, 2023



Measure C – Objective

To preserve the City's long-term financial stability and maintain City and public safety services, including police patrols and fire protection; 9-1-1 emergency response; rapid response to gang violence, robberies and burglaries; park safety; youth/senior services; job creation and other city services, shall the City of Lathrop enact a 1 cent sales tax with all money for Lathrop and no money for Sacramento, requiring independent Citizens' Oversight and published annual audits.





Measure C - Background



2011

At the direction of the City Council, City Staff and LMFD worked together to create Measure C, a local sales tax that would provide for maintaining and enhancing services to our residents.

2012

At the November 6, 2012 election -The Measure was approved by more than 77% of the participating Lathrop voters.

2013

The City entered into an agreement with LMFD to allocate 40% of the total Measure C revenues received to the District to augment and enhance fire protection services within the City.

The City began receiving revenue from Measure C in September 2013.



Purpose and Jurisdiction

- The Measure C Community Oversight Committee reviews expenditures of revenue collected pursuant to Lathrop Municipal Code Chapter 3.13 only, to determine whether such funds are expended for the purposes specified in Chapter 3.13.
- Per Lathrop Municipal Code 3.13.180 (D)
 - In order to preserve the integrity and independence of the oversight process, committee members will not play a formal role in contracting, project management, or any other aspect of Measure C funding.
 - The committee is not charged with decision-making on spending priorities, schedules, project details, funding source decisions, financing plans, or tax rate assumptions.
 - The Committee shall serve in an advisory-only role to the City Council.



Accomplishments



Public Safety Lathrop Manteca Fire District

- Funded 9 Firefighter Positions
- Funded 1.98 Battalion Chiefs
- Funded overtime provided for constant staffing at Fire Stations in the City of Lathrop
- Funded Deputy Fire Marshal Position (funded at Mid-Year)

Public Safety Lathrop Police Department

- Funded 5.5 Sworn Police Positions
- Added a Lieutenant and an SRO position (funded at Mid-Year)
- Completed Transition to City of Lathrop Police Department

Parks and Recreation


- Funded 4 positions
- Funded the Maintenance and Operations (M&O) costs related to Lathrop Generation Center.

Accomplishments Cont.

City Projects

Funded Community Projects totaling \$1.54 million approved by Council:

- Upgrades of Park facilities throughout the City: installation of fitness equipment, benches, barbeque areas, waste receptacles, water and pet fountains, parking lot repairs at Valverde and additional parking at the Generations Center.
- Purchase of Automated License Plate Readers (ALPR) for enhanced law enforcement.
- Install Citywide Fiber network
- Upgrades to Milestone Manor Park
- Installed rubberized surface at various City Parks.




Goals

• Continue to fund support positions and M&O costs for the Lathrop Generation Center.



- Fund installation of marquees at the Community Center and the Generations Center. (PK24-02) \$80,000


