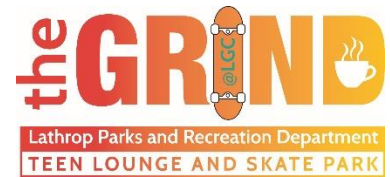

RELEASE AND WAIVERS OF ALL LIABILITY AND ASSUMPTION OF RISK AGREEMENT

Hold Harmless and Parent/Guardian Indemnify Agreement Liability Information

In consideration for myself and my minor children being permitted by the City of Lathrop Parks & Recreation Department to participate in activities I hereby release and hold harmless to the fullest extent permitted by law the **City of Lathrop, its employees, officers, officials, agents and volunteers** for any and all injury, disability, death, or loss or damage to person or property, arising from my participation in the above activity, including my use of equipment or facilities, including any such claims which allege negligent acts or omissions to the extent permitted by law; I hereby waive, release and discharge in advance the City from any and all liability arising out of or connected in any way with my participation in said activity, even though that liability may arise out of negligence or carelessness on the part of the released parties referenced as "City" above. I understand that this activity involves risk and danger of accidents and knowingly assume those risks by my signature below. It is further agreed that this waiver, release and assumption of risk is to be binding on my relatives, heirs and assigns. I agree to indemnify and to hold the **City of Lathrop, its employees, officers, officials, agents and volunteers** free and harmless from any loss, liability, damage, cost, or expense which they may incur as the result of my death or injury or property damage that I may sustain while participating in said activity. The described activity may be of hazardous, strenuous, and/or physical nature. Participation in the described activity may occasionally result in bodily injury, personal injury, sickness, disease, death or property loss or damage, arising from the coronavirus disease ("COVID-19"), and the severe acute respiratory syndrome coronavirus 2 ("SARS-CoV-2"). I acknowledge the contagious nature of COVID-19 and other communicable diseases and voluntarily assume the risk that I may be exposed to, or infected by COVID-19 by participating in the above activity, and that such exposure or infection may result in personal injury, illness, permanent disability, and death. Knowing the risk involved, nevertheless, I voluntarily request permission for myself or minor child to participate in the described activity. In the event that said minor requires medical or surgical treatments while under the supervision of said city personnel in connection with the described activity, such supervision may authorize treatment. I will pay all medical, hospital, or other expenses which I or my minor children may incur as a result of such treatment. I attest that I have no known medical conditions, and have not used any form of alcohol or drugs (prescription or non-prescription) that could jeopardize my safety, or the safety of others during this activity. I should not enter and participate in the activity unless I am medically able and properly trained. I agree to abide by all rules, regulations and instructions of the activity, as well as all applicable municipal and state laws and regulations.

I expressly permit said minor child to travel by private automobile to activities and events related to the described activity.

Activities are not child care as defined by the State of California.

I understand city staff may photograph or videotape me and/or my minor children and the city may use such photographs or videotapes to promote city programs and classes. I expressly allow, and hereby waive any objection to, the City's photographing and/or videotaping of me and/or my minor children when I and/or my minor children are participating in a city recreation program. I understand all photos and videotapes will remain the property of the City of Lathrop. I certify that I have custody or am the legal guardian of said minors. I further understand and consent that I will periodically be receiving communications related to my participation in the activity.

FOR VIRUTAL CLASSES AND PROGRAMS: I also hereby warrant and agree, that the conditions of my environment are safe, free from obstructions, and are suitable for participation in the above-referenced activity. I further understand and agree that any material downloaded, viewed or otherwise obtained through my participation in said activity is done at my own risk and the City is not responsible for any loss, alteration, corruption or other damage to my personal property, including computers, networks and other property used as part of my participation. I expressly agree that this waiver is intended to be as broad and inclusive as is permitted by the laws of the State of California. I, the undersigned participant, have carefully read this Assumption of the Risk, Waiver and Release of Liability and fully understand its contents. I am aware that this is a release of liability and a binding contract between myself and the City of Lathrop, and I sign it of my own free will. I understand that I am giving up substantial rights, including my right to sue. I acknowledge that I am signing this Waiver and Release freely and voluntarily and intend by my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.

The Grind @ LGC Membership Packet

The Grind @ LGC is a safe place for teens currently enrolled in 7th - 12th grade (**with valid Student ID**) to gather and socialize with friends after school. A completed Membership Form is required for registration. The membership is free. The Membership form must be signed by both the participant and the parent/guardian. Membership is valid as long as the participant is a 7th - 12th grade student. The Grind @ LGC operates on a drop-in format. Participants are free to come and go as they choose.

24/25 School Year Operating Hours (dates and times are subject to change).

- The Grind @ LGC follows the MUSD student calendar.
- Monday-Thursday 3:30pm-6:00pm, and Fridays-Saturdays 3:30pm-5:00pm,
- The Grind @LGC will accommodate minimum day schedule; opens at 1:30pm
- In the event of an unscheduled district school closure or power outage, The Grind @ LGC will also be closed.

Participant Responsibilities

- Participants shall be courteous and respectful of adults, staff and fellow participants.
- Participants shall obey rules of the facility.
- Participants shall show respect for City property and the personal property of others.
- **All teen programs have a zero tolerance policy for any type of physical fighting, harassment, drug or alcohol use.**

Enforcement of Facility Rules:

Facility rules will be enforced at all times while on City property, including outdoor amenities.

Participant Behavior:

If a participant becomes aware of any potentially dangerous and/or illegal situations regarding weapons, drugs, alcohol, fights, property damage, theft, etc., or has information regarding such, he/she is requested to report it to a staff member.

Education Code 48909:

California State Law makes parents fully responsible for losses of and damage to school and City property by students.

Suspension:

Any participant suspended from school will also be suspended from The Grind @ LGC.

Participant Behavior Standard (Rules & Regulations)

A Participant Behavior Standard and Discipline Plan were developed to inform parents/guardians and participants how we expect them to behave while they are participating in our programs and at our facilities. We expect all participants to follow the values of Honesty, Respect, Caring, Responsibility while members of the Teen Center program. Parents/guardians and participants should review this Standard and Discipline Plan so there is clear understanding of behavior expectations and consequences of actions. Both parents/guardians and participants will be asked to sign a Behavioral Contract indicating support of the Participant Behavior Standard and Discipline Plan. Please note that the Lathrop Generations Center includes the following amenities: The Grind @ LGC, the Skate Park, Parkour Park, Basket Ball Court, Pickleball Court, Amphitheatre, and Café. In order to keep all the teen programs running strong and free of major discipline issues, participants must be held

accountable for all program policies. The City of Lathrop Parks and Recreation staff will enforce all standards. The following standards are to ensure the safety of all members and staff.

Loitering	Participants are not to loiter in front of the Lathrop Generations Center, in the lobby and the parking lot.
Personal Belongings	Participants are responsible for their own personal belongings at all times when participating. Participants must take their personal belongings if they are to leave the center for any reason. The City is not responsible for property left unattended.
Skateboards, Scooters, Skates, ETC.	Will NOT be allowed to ridden inside of the center. Skateboards will not be allowed to be left in front of entrances and exits. Please be considerate, pick up, and hold the items while inside the building.
Bikes	Will NOT be allowed inside nor will they be allowed to store in front of the Lathrop Generations Center entrance. There are designated bike racks that can be used to lock up bikes. The City will not be responsible for bikes not properly secured.
Interpersonal Relationships	Appropriate personal relationships are encouraged. The Lathrop Generations Center policy is one of "hands-off". Holding hands, arm-in-arm, sitting on laps, hugging and kissing are not appropriate while at the Lathrop Generations Center. Sexual harassment will not be tolerated.
Swearing / Profanity	Swearing, profanity or vulgar language will not be tolerated. Participants will be counseled to be aware of their language. The circumstances will determine if more severe consequences are needed.
Defiance / Refusal to Obey Authority	Participants are expected to follow the instruction of Parks & Recreation Department staff. If a participant disobeys any City of Lathrop employee either by action or words, he/she will be considered defiant. Severe defiance will result in suspension; and/or loss of membership privileges.
Vandalism	Damaging City property or the property of others will not be tolerated. A police report will be filed. Parents will be liable to pay for damages.
Theft	Participants have the responsibility of taking care of their own possessions. Make sure that bicycles are locked. Money should be kept in a safe place at all times. Theft is a serious violation of the law and will be dealt with severely. Participants are discouraged from bringing large amounts of money or valuable items to the Lathrop Generations Center.
Gambling	Any form of gambling is prohibited. Defiance of this rule will result in suspension; and/or loss of membership privileges.
Possession of Tobacco and Smoking	If a participant of the Lathrop Generations Center has in his/her possession, tobacco or cigarettes, E-cig, cigarette lighter, or matches, this is grounds for suspension. Participants who are around others who are smoking should make a responsible decision to remove themselves from the area. Otherwise, they, too, may be suspended.

	The City of Lathrop Police Department will be notified when participants are in possession of tobacco products.
Illegal Substances, Drugs, And Alcohol	Use of or possession of any illegal substances, drugs or alcohol at the Lathrop Generations Center or at any City-sponsored activity will be reported to the City of Lathrop Police Department and is grounds for immediate expulsion from Center.
Graffiti Substances	Permanent felt pens, aerosol spray cans of any type, glue, and white out are not to be brought to the Lathrop Generations Center.
Weapons / Dangerous Items	State law requires that a participant be expelled for possession of any weapon of any kind to include but not limited to: firearm, knife, explosive or other dangerous object is strictly prohibited at the Lathrop Generations Center or at a City-sponsored activity on or off school grounds.
Harassment/Hate Crimes	It is not permissible to harass others while at the Lathrop Generations Center. The City of Lathrop Police Department will be notified and all applicable state and federal laws will be enforced.
Hazing	Matt's Law SEC.3. Section 245.6 is conduct which causes, or is likely to cause, bodily danger, physical harm, or personal degradation or disgrace resulting in physical or mental harm to another person in the course of the other persons pre-initiation into, initiation into, affiliation with, holding office in, or maintaining membership in any organization.
Gangs	Wearing, carrying or physically displaying gang paraphernalia or making gestures that symbolize gang membership is prohibited. Engaging in an activity that is gang related is prohibited.
Fighting is Prohibited	Participants are to use staff and administrators to discuss problems they are having with other participants. If a fight occurs, all participants, including bystanders who provoke and encourage such behavior, will be subject to suspension. Lathrop Generations Center administrators will recommend a participant's expulsion for causing serious physical injury to another person, except in self-defense.
Serious Injury or Attempting to Cause	If a participant attempts to cause serious injury to another person, except in the case of self-defense, it will recommended they be expelled from the Lathrop Generations Center. The City of Lathrop Police Department will be notified and all applicable state and federal laws will be enforced.
Assault and Battery	It is not permissible to commit assault or battery upon others while at the Generations Center. The City of Lathrop Police Department will be notified and all applicable state and federal laws will be enforced.
Assault, Sexual/Battery	It is not permissible to commit sexual assault or battery upon others while at the Generations Center. The City of Lathrop Police Department will be notified and all applicable state and federal laws will be enforced.
