



ITEM: **COUNCIL APPROVE 2026 FACILITY FEE WAIVER REQUESTS FROM LATHROP LITTLE LEAGUE, ALCOHOLICS ANONYMOUS AND LIFT YOUR HEAD UP THERAPEUTIC HOMES, INC.**

RECOMMENDATION:

- 1. Approve a Facility Fee Waiver Request from Lathrop Little League; and**
- 2. Approve a Facility Fee Waiver Request from Alcoholics Anonymous; and**
- 3. Approve a Facility Fee Waiver Request from Lift Your Head Up Therapeutic Homes, Inc.**

SUMMARY:

The Parks and Recreation Department received facility fee waiver requests from Lathrop Little League, Alcoholics Anonymous and Lift Your Head Up Therapeutic Homes, Inc., in accordance with the City of Lathrop Fee Waiver Policy.

BACKGROUND:

Council adopted a City of Lathrop Fee Waiver Policy, which conditionally allows fee waivers for entities that qualify as one of the following: Intergovernmental Cooperation, Lathrop Non-Profit including 501(c)3 and/or 501(c)4 with valid status and a Lathrop address, or a Lathrop organization with financial hardship directly benefiting the Lathrop community, such as a community group without non-profit status. The facility fee waiver requests from each organization are listed below. All fees include both facility and staff costs.

- **Lathrop Little League** **\$2,284.22**
Lathrop Little League is a local non-profit providing enriching youth programming that promotes sportsmanship, teamwork, and leadership skills through the game of baseball. Lathrop Little League submitted a facility fee waiver for the use of six Baseball Diamonds for practices, Monday through Friday from 4:30 p.m. to 7:30 p.m. from June 8, 2026, through June 26, 2026.

- **Alcoholics Anonymous** **\$2,354.75**
Alcoholics Anonymous is a local non-profit with a mission to help its members find sobriety. Alcoholics Anonymous submitted a facility fee waiver request for the use of the Lathrop Community Center Multi-Purpose Room on Thursday evenings from 6:00 p.m. to 8:00 p.m. to host their weekly meetings.
- **Lift Your Head Up Therapeutic Homes, Inc.** **\$885.10**
Lift Your Head Up Therapeutic Homes, Inc., is a local non-profit providing support and a safe structured environment that fosters a culture of positivity, self-advocacy, growth, and self-sufficiency to at-risk youth. Lift Your Head Up Therapeutic Homes, Inc., submitted a facility fee waiver request for the use of the Lathrop Senior Center on December 19, 2026, from 1:00 p.m. to 9:00 p.m. to host a Youth Christmas Gala supporting the youth of Lathrop with an estimated attendance of 80 participants.

RECOMMENDATION:

Staff recommends the Parks and Recreation Commission find the requested facility fee waivers would provide a public benefit to the community and the amount of the request is de minimis in nature and not subsidized from other facility fees and recommends Council approve the facility fee waiver requested by Lathrop Little League, Alcoholics Anonymous and Lift Your Head Up Therapeutic Homes, Inc.
