

# Start a Recycling Program in 3 Easy Steps

- trash. Determine what is being thrown away that can be recycled. Chances are it's a LOT! Many businesses that have a recycling program in place save substantially on their trash bill by having less frequent trash pick-up services.
- 2. Select Your Program If you have a four yard waste container or more than 5 residential units, you must have a recycling program in place. Your program may be as small as CRV or a paper recycling program. If the waste audit shows that you have a lot of material that can be recycled (and you probably do), contact your refuse collector. Collectors are required to provide recycling options for business and multi-family residences. Contact information for refuse collectors in San Joaquin County is listed on the back of this brochure.
- the Word Make it easy to recycle by placing signs and distributing bins in the workplace, jobsite, agency or complex. Place them by the copier, under each desk, in the lunchroom and by entrances and exits. For multi-family complexes, provide recycling containers for each tenant. Talk to your employees, coworkers or tenants about your new recycling program. Recycling programs are more productive when employees or residents are on board. Designate a recycling leader or form a team to oversee the program.

## What can be put in the recycling bin?

- Clean, dry paper junk mail, file folders, school paper, printer paper, colored paper, shredded paper
- Newspapers, magazines, catalogs and phone books
- Cardboard boxes
- Clean, empty pizza boxes, frozen food boxes and shoe boxes
- Cereal boxes without the liner
- Non-foil gift wrapping paper
- Plastic containers and bottles
- Glass bottles and jars
- Metal and aluminum cans, TV trays or pie pans

### What should **NOT** be put in the recycling bin?

- NO Contaminated or wet paper
- NO Plastic toys or hangers
- NO Diapers
- NO Plastic bags\*
- NO Tires\*
- NO Hazardous Waste\* paint, antifreeze, oil, batteries, pesticides, cleaning products, fluorescent bulbs, medications, medical sharps, appliances, cell phones, TVs, computers and monitors.
