## 9. SCHEDULED ITEMS

9.1 Sandoval Truck Trailer Parking – Louise Site Plan Review No. SPR-20-73

Mr. Niskanen made the staff report presentation. He pointed out a proposed modified condition allowing full turn movements in/out of the site until Louise Ave is constructed to its ultimate build-out and a center median is installed.

Commissioners Rhodes, Dresser and Gatto were concerned about traffic if full turn movements are allowed. A discussion on Louise Ave traffic and turn movements ensued. Mr. Gebhardt explained that the decision to modify the condition is because most businesses in the area were allowed the same full turn access. He added that traffic was not an issue in the area since most truck traffic happens on off peak hours. He also pointed out that the City has the option to extend the median to stop the left in/left out movements if traffic problems arise.

Vice Chair Dresser asked if the condition will allow the City to revisit and reevaluate the traffic impacts of the project in the future. Mr. Gebhardt ensured that the City has the discretion to install the medians when necessary. Commissioner Gatto wants assurance that the applicant agrees with this.

Commissioner Rhodes urged staff to keep in mind the need to balance the uses on future developments in the area.

Zach Wong, project engineer, talked briefly about the project. He assured the commission that trailer parking will not create a lot of traffic due to its low use.

Commissioner Ishihara is concerned about hazards during foggy season.

#### 8 PUBLIC HEARING ITEMS

8.1 River Islands Modified Phase 2 Project.

Commissioner Rhodes recused herself and left the chamber during item discussion.

Mr. Meissner gave a brief outline of the items for discussion and introduced the project consultants, JB Anderson and Ascent Environmental, to help answer questions regarding the project. Messrs. Meissner, Anderson and Niskanen made the staff report presentation. Mr. Niskanen announced that staff has received four correspondence as comments to the project; copies were provided to the Planning Commissioners prior to the meeting.

Commissioner Ishihara complemented River Islands Staff and City staff for working together to come up with a well-written report.

## OPENED PUBLIC HEARING

Ms. Dell'Osso came forward and commended her staff, City Staff and the consultants for the tremendous amount of work done on the project. She made a video presentation on the River Islands project. She also addressed each comment received regarding the project.

# **CLOSED PUBLIC HEARING**

Mr. Navarrete entered into record a letter received from the California Valley Miwok tribe accusing the City of failing to meet and confer with the tribe regarding the project. Mr. Navarrete gave assurance that the City has met all SB-18 and AB-52 requirements. Planning Commissioners received a copy for their review.

Vice Chair Dresser asked the meaning of "Residential Low" on the project summary table. Mr. Meissner explained that this refer to density and not affordability level.

Vice Chair Dresser asked staff to explain the significant and unavoidable conclusion for agricultural resources and GHGs. Sean Bechta of Ascent Environmental explained that, although money and efforts were made to create conservation easements to mitigate loss of Ag land, it is not the same as creating new Ag land; therefore, [in the CEQA sense] that makes it unavoidable. Regarding GHGs, a new calculation analysis found that GHG emissions per capita is more efficient on the modified project than was foreseen before. However, despite

making every effort to meet state standards, a "significant and unavoidable" conclusion was made because it is not possible to guarantee that standards can be met 100%.

Commissioners Gatto and Ishihara commended the developer, River Islands, for consistently going above and beyond the requirements.

Chair Ralmilay asked if there is a timeframe for the widening of Paradise Cut. Mr. Gebhardt explained that the bridge is expected to be needed by 8 years with design/permitting to start in 2021.
