9.1 River Islands – Old River Neighborhood Design Plan (NDP) & Architectural Design Guidelines and Development Standards (DG/DS) NDP-21-93

Mr. Niskanen made the staff report presentation. Mr. Ramon Batista of River Islands came forward to answer questions from the commissioners and the public regarding the project.

Commissioner Gatto asked who is responsible for the repair and maintenance of wood fences. Mr. Batista replied that RIPFA maintains fences along major thoroughfares whereas the homeowners maintain neighborhood fences.

Commissioner Ralmilay asked how many additional schools are planned for the project. Mr. Batista replied that there are plans to build four additional K-8 schools in Phase 2. With the rapid increase in home sales, they are anticipating to build a school sooner than anticipated. Mr. Batista gave a brief school construction timeline/update.

Chair Dresser inquired about gray water/recycled water availability. Mr. Batista replied that there are non-potable irrigation water sources available for public facilities but there is none available for residential use. Chair Dresser is also concerned about government plans to limit water usage. Mr. Batista remarked that the water situation is unprecedented; however, the state has not yet mandated any drought restrictions. Mr. Caguiat added that there is a shift towards drought resistant landscaping to save water.
