8. PUBLIC HEARING ITEMS

8.1 Municipal Code Text Amendment No. TA-21-116

Mr. Niskanen made the staff report presentation.

Commissioner Ralmilay asked if Cannabis could be sold to minors. Mr. Niskanen explained that sales to minors are allowed for medical purposes only; recreational cannabis sales will only be allowed for adults 21 years and older.

Commissioner Dresser asked if there is a trial period for the dispensary. Mr. Niskanen replied that there is none. Mr. Meissner added that the development agreement and conditions of approval would regulate performance and require annual review.

Commissioner Rhodes recommended strong police presence and careful monitoring of the dispensary.

The Commissioners were concerned about allowing a dispensary in commercial areas where families frequent. There was also a concern about the dispensary's compatibility with the surrounding businesses. A discussion ensued on allowing dispensaries in various commercial zoning designations. Staff fielded questions throughout the discussion.

OPEN PUBLIC HEARING

Gene Neely, resident, asked if the dispensary location is chosen based on state laws. Mr. Niskanen replied that jurisdictions have an option to limit the location. Mr. Neely recommended allowing the dispensary in industrial areas. He observed that dispensaries in other Cities are in industrial areas where it can maintain a low profile and it can easily be monitored.

CLOSED PUBLIC HEARING

Following the discussion, Mr. Niskanen summarized the Commission recommendations as follows:

- Remove the following Zoning Districts: Regional Commercial-River Islands, Neighborhood Commercial, Service Commercial-Mossdale Village, Commercial Office-Central Lathrop, and Village Commercial-Mossdale Village.
- Allow the cannabis dispensary to operate in the Industrial Zoning Districts (Limited Industrial and General Industrial), subject to the approval of a Conditional Use Permit.
- Increase the City Council recommended buffer from 1,000 feet to 1,500 feet on Lathrop Road/Spartan Way and Golden Valley Parkway.

Moved by Vice Chair Rhodes, Second by Commissioner Ralmilay to adopt Resolution 21-23 recommending City Council adopt an ordinance amending Chapter 5.26, Prohibition against Commercial Cannabis and Title 17, Zoning, Chapter 17.18, Prohibited Cannabis Activities (TA-21-116), as amended with Planning Commission recommendations.
