#### 8. PUBLIC HEARING ITEMS

# 8.1 Municipal Code Text Amendment No. TA-21-151

Mr. Niskanen made the staff report presentation.

Referring to the proposed amendment for beauty salons and barbershops, Commissioner Rhodes asked staff to define "Mobile Unit". Staff explained that the State Board of Barbering and Cosmetology now issues licenses to operate fully equipped mobile salon/barbershop trailers that can provide services at customers' homes. Where before, Lathrop Home Occupation (HOC) standard does not allow barber and beauty shop services at all, staff proposes to allow HOC permits for those licensed by the State Board of Barbering and Cosmetology as mobile businesses. However, trailers stored at home must be located at an approved location per Lathrop Municipal Code.

Commissioner Rhodes want to remind residents to be courteous and mindful of site visibility when parking RVs in front of homes.

Commissioner Ralmilay is concerned about the proximity of the project to the Harlan Rd signal lights. Mr. Gebhardt explained that a new signal will be installed near the project and signal timing will be coordinated to minimize traffic impact in the area.

Commissioner Ishihara recommended possibly adding EV charging stations to the project in the future.

Christie Hutchings, applicant, talked about how they are excited to come to the City since this is one of their vey first locations in California. She praised staff for an excellent project presentation; she offered to answer any questions from the commission.
