9. SCHEDULED ITEMS

9.1 General Plan Housing Element Annual Progress Report for Calendar Year 2022

Mr. Niskanen made the staff report presentation.

Commissioner Jackson asked if the developers are required to build affordable housing. Mr. Niskanen replied that the housing element only requires the City to demonstrate there is adequate land to accommodate such projects. Mr. Caguiat added that it is difficult to attract affordable housing developments because there is only specialized type of developers who are willing to undertake such projects and there is the challenge of prohibitive construction costs as well.

Commissioner Jackson inquired about any state incentives for affordable housing projects. Mr. Caguiat replied that there are currently no state incentives available but the City offers different incentives in the municipal code (such as density bonuses, etc) that could support these developments.

Commissioner Ralmilay asked if there are more residential building permits this year than last year. Staff replied that there were more building permits pulled last year however this year's numbers are still high. They explained that the sudden rise in interest rates has caused residential sales to decline.
