#### 8. PUBLIC HEARING ITEMS

## 8.1 Housing Element Update No. GPA-24-159

Mr. Michaels introduced Beth Thompson of Denovo Group; the firm contracted to assist in updating the City's 6<sup>th</sup> cycle of the Housing Element. Ms. Thompson proceeded to make the staff report presentation.

Commissioner Jackson expressed his frustration at the City's lack of response to affordable housing. He is surprised that it is still not yet a requirement for every City. A discussion on the availability of affordable housing opportunities ensued. Ms. Thompson pointed out that Progs. 1 & 2 of the Housing Element addresses the requirement for a more aggressive approach in seeking affordable housing. Commissioner Rhodes added that, for the State to make affordable housing mandatory, it will have to offer some kind of financial mechanism to help the cities achieve the goal of affordable housing.

Commissioner Rhodes remarked that she was glad that the City is meeting the housing requirements and commended River Islands for being a big part of the City's residential development. She asked staff how progress is communicated to the citizens. Mr. Michaels replied that information is always available thru the City website. Commissioner Rhodes recommended finding alternate ways to reach out to citizens especially those with limited internet access or are not technologically savvy. Mr. Michaels assured Commissioner Rhodes that staff will take the recommendation under advisement.

Commissioner Ishihara added that the City could not really do anything if developers and builders are not interested in building affordable housing projects

Chair Ralmilay asked if there were any grants available for affordable housing. Mr. Michaels replied that there are no grants available for affordable housing at this time.

Chair Ralmilay pointed out Table 5.7 does not include the Banta Unified School District statistics. Ms. Thompson responded that it will be added to the report.
