Commissioner Camarena asked what would happen if any of the projects is not finished within the budget years. Mr. Taylor explained that some projects are projected to carry forward to future budget years due to time & budget constraints. These can extend project timelines beyond the budget years.

Commissioner Camarena asked for an update on the Louise Ave Interchange Project. Mr. Taylor replied that it is in the environmental phase and is anticipated to start construction by the summer of 2027.

Commissioner Camarena also asked about the Manthey Bridge Project. Mr. Taylor replied that staff are still responding to state requirements regarding environmental issues. Construction is anticipated by 2027.

Chair Ralmilay asked about tree trimming schedules within the City. Mr. Taylor explained that tree trimming is not a CIP project but is a maintenance budget item. However, he is aware that Mossdale Village is on schedule for tree trimming.
