8.1 Housing Element Update No. GPA-19-140

Mr. Meissner introduced Beth Thompson of Denovo Planning, Housing Element Update Consultant. Ms. Thompson proceeded to make the staff report presentation.

Commissioner Dresser asked what will happen to the allocations if SB-5 is not resolved. Ms. Thompson replied that developments in other parts of the City may be able to accommodate the allocations. Commissioner Dresser also asked if there are other sources of funds like Measure C that can help subsidize housing needs. Mr. Navarrete replied that General Funds (Measure C) are available, however, the City would have to consider if this is the type of expenditure these funds are intended for, as the public perceives.

Commissioner Dresser asked if building height restrictions can be adjusted to accommodate housing needs. Mr. Meissner replied that this could be considered but might not be necessary as the City has plenty of land available to accommodate the needs allocation.

Commissioner Ralmilay asked about General Fund limits for use on these types of developments. Mr. Navarrete replied there is no legal limit assuming that the funds are available.

Chair Gatto commented that that the City will eventually need to find a way to provide senior housing.
