The work to be performed under this contract is generally described as, but not necessarily limited to; grind and dispose existing pavement surface, install glass grid, 3" of new Hot Mix Asphalt overlay with shoulder backing, install new thermoplastic striping, construct a drainage swale, and perform all appurtenant work in place and ready for use, all as shown in the Contract Plans and Specifications.

Pursuant to Labor Code Section 1725.5, all Subcontractors identified in a Bidder's Subcontractors' List shall be DIR Registered Contractors. If awarded the Contract for the Work, at all times during performance of the Work, the Bidder and all Subcontractors, of any tier, shall be a DIR Registered Contractors
