The Project is located southeast of the intersection of West Stewart Road and Cirrus Court, Lathrop California. The work to be performed under this contract is generally described as, but not necessarily limited to the construction of aquifer storage and recovery (ASR) well injection equipping improvements, including: connection to an existing City drinking water main, installation of yard piping, modifications to existing storage tank inlet piping, construction of a concrete wellhead, installation of wellhead mechanical improvements, construction of a "chemical canopy" steel structure, installation of wellhead treatment chemical systems (carbon dioxide and sodium hypochlorite), installation of electrical and instrumentation facilities, and commissioning of the Work. This contract also includes ongoing well-backflushing, testing, and water quality sampling for a period of 12 months following completion of the wellhead improvements.

DIR Registration. Bidder must submit proof of DIR Registration with Bid Proposal, no exceptions. Pursuant to Labor Code Section 1725.5, all Subcontractors identified in a Bidder's Subcontractors' List shall be DIR Registered Contractors. If awarded the Contract for the Work, at all times during performance of the Work, the Bidder and all Subcontractors, of any tier, shall be a DIR Registered Contractors
