In order to be accepted for recycling, each load must contain at least 65% by weight of the following materials:

CARDBOARD (OCC)

Styrofoam, film plastic & other contents of cardboard boxes must be removed

DRYWALL (Gypsum Wallboard/Sheetrock)

INERTS

Concrete / Asphalt/Bricks

Dirt / Soil / Gravel

Porcelain Sinks/Toilets/Counter Tops

Ceramic Floor Tile & Used Roof Tiles

METALS

Scrap Metals

Steel, Aluminum, Copper

Appliances - separate fees apply

PLASTICS

Plastics Coded #1, 2, 4, 5 and 7

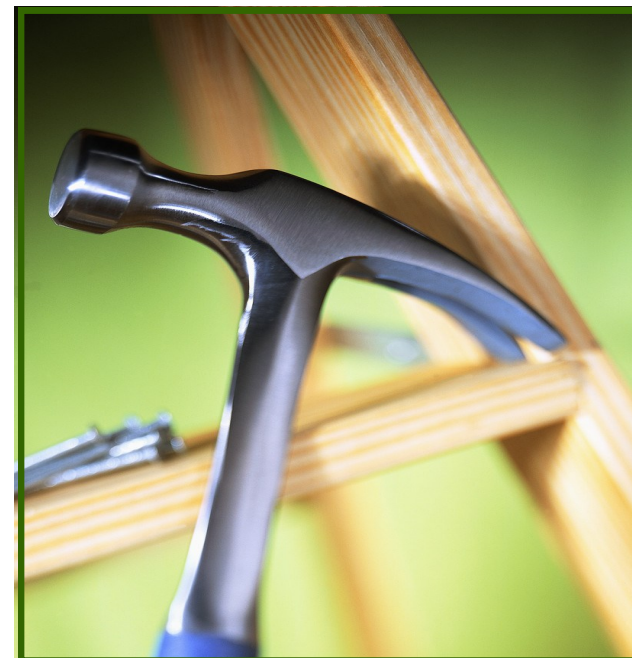
Tarping Requirement: All loads taken to County facilities must be covered. Loads that are not covered with a tarp or other cover shall be subject to additional charges.

The City of Lathrop requires construction, demolition and renovation projects to dispose of their job site waste in an environmentally responsible manner. The City of Lathrop's requirements are in accordance with Assembly Bill (AB) 939. The City of Lathrop's requirements follow: **CALGreen** - *California's Green Building Standards Code*. CALGreen promotes environmentally responsible, cost-effective, healthier places to live and work. The CALGreen building code waste diversion requirements state that at least 65% of construction materials generated during new construction or demolition projects shall be diverted from the landfill. The City considers the reuse and recycling of C&D debris essential to compliance with AB939.

The City of Lathrop helps contractors meet the new State CALGreen requirements. Studies show that nearly 22% of all waste disposed of in California is C&D debris. The reuse and recycling of C&D debris is essential to meet the diversion requirement of 65%. Please refer to the CALGreen website for more information on requirements of 65% C&D diversion.

City of Lathrop Construction & Demolition Recycling Requirements

	Construction	Demolition	Additions/Alterations/Tenant Improvements
Agricultural	All New	All New	Increase of conditioned area (including roofline changes to a barn) Under CALGreen standards, there are NO exemptions for ag related projects.
Non-Residential	All New	All New	Increase of conditioned area (including roofline changes to a business)
Residential	All New	All New	Increase of conditioned area (including roofline changes to a home)
Subdivision	All New	All New	Increase of conditioned area, volume or size

Conditioned Floor Area (CFA) is the floor area (in square feet) of enclosed conditioned space on all floors of a building, as measured at the floor level of the exterior surfaces of exterior walls enclosing the conditioned space.

DONATIONS: People performing C&D projects may also increase recycling rates, save money on disposal costs, and may receive a tax write-off by donating items such as light fixtures, sinks, faucets, doors, etc to organizations such as Habitat for Humanity ReStore (209-463-1043) or the ReUse People (209-241-3614). Please contact these organizations directly for additional information.

Projects not applicable or Exempted:

- ♦ **Stucco & Siding Projects** No routing/No fee required.
- ♦ **Window Replacements** No routing/No fee required.
- ♦ **Grading Projects** No routing/No fee required.
- ♦ **Pre-Fab Buildings/Barns/Green Houses** No fee required. Need to obtain letter or invoice from manufacturer demonstrating pre-fab.
- ♦ **Hazardous Waste Projects** Route to San Joaquin County. No fee required
- ♦ **Patios/Pergolas/Carports** (Attached & Detached) – N/A (Not applicable because they are not conditioned area.)
