In order to ensure all persons have the opportunity to speak, a time limit will be set by the Chair for each speaker (see instructions on speaker form). In the interest of time, each speaker may only

Speak once on each individual agenda item; please limit your comments to new material; do not repeat what a prior speaker has said.

## **Citizen's Forum**

Any person desiring to speak on a matter which is not scheduled on this agenda, may do so under the Public Comment section. Please submit your blue speaker card to the Youth Advisory Commission Secretary prior to the commencement of Public Comment or submit your request to speak via the "raise hand" feature in ZoomGov.
